

NOTICE OF PUBLIC HEARING

TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS MULTIFAMILY HOUSING REVENUE BONDS (PALLADIUM OLD FM 471 W)

Notice is hereby given of a telephonic public hearing to be held by the Texas Department of Housing and Community Affairs (the “Issuer”) on August 29, 2023, at 10:00 a.m. All interested parties are invited to call in to express their views with respect to the Development and the issuance of the Bonds, each as described herein. Interested parties may join the public hearing on the date and the time indicated above by dialing 844-867-6169 (US Toll Free) and, when prompted, entering the access code 5125072#.

The hearing is regarding the issuance of obligations by the Issuer, which may be issued pursuant to a plan of finance in one or more series, in an aggregate principal amount not to exceed \$37,850,000 (the “Bonds”). The Bonds will be issued as exempt facility bonds for a qualified residential rental project pursuant to section 142(a)(7) of the Internal Revenue Code of 1986, as amended (the “Code”). Proceeds of the Bonds will be loaned to Palladium Old FM 471 W, Ltd., a Texas limited partnership or an affiliate thereof (collectively, the “Borrower”) to partially finance an affordable multifamily housing development, Palladium Old FM 471 W, that will be located at or near Old FM 471 W and Talley Road, San Antonio, Bexar County, Texas 78253 (the “Development”). The Borrower will be the initial owner and principal user of the Development.

Any interested persons unable to dial into the hearing, but who would like to express their views on the Development and the issuance of the Bonds may submit their views in writing to Liz Cline-Rew via standard mail or e-mail on or prior to October 3, 2023.
