

NOTICE OF PUBLIC HEARING

TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS  
MULTIFAMILY HOUSING REVENUE BONDS  
(CHAMPION'S CROSSING)

Notice is hereby given of a telephonic public hearing to be held by the Texas Department of Housing and Community Affairs (the "Issuer") on March 11, 2022, at 11:00 AM. All interested parties are invited to call in to express their views with respect to the Development and the issuance of the Bonds, each as described herein. Interested parties may join the public hearing on the date and the time indicated above by dialing 844-867-6169 (US Toll Free) and, when prompted, entering the access code 1787501#.

The hearing is regarding the issuance of obligations by the Issuer, which may be issued pursuant to a plan of finance in one or more series, in an aggregate principal amount not to exceed \$20,000,000 (the "Bonds"). The Bonds will be issued as exempt facility bonds for a qualified residential rental project pursuant to section 142(a)(7) of the Internal Revenue Code of 1986, as amended (the "Code"). Proceeds of the Bonds will be loaned to EC Champions Crossing, LLC, or an affiliate thereof (collectively, the "Borrower") to finance an affordable multifamily housing development to be known as Champion's Crossing (the "Development") that will be located at or near 345 Champions Boulevard, San Marcos, Hays County, Texas 78666. The Borrower will be the initial legal owner and principal user of the Development.

Any interested persons unable to dial into the hearing, but who would like to express their views on the Development and the issuance of the Bonds may submit their views in writing to Jon Galvan via standard mail or e-mail on or prior to April 5, 2022.
